Terms and Conditions of the Contest

Participation in the lottery draw

All the adult visitors to the exhibition, who fill in the lottery ticket, may participate in the lottery draw.

Lottery tickets are given free of charge at the Seafood Expo Global, Hall 6, Pavilion 901. The Members of the Board of Directors of HAPO, the employees of companies that are Members of HAPO, employees of HAPO and associates, are prohibited from participating in the draw.

Each participant may fill in only one (1) lottery ticket.

Duration of the contest

The contest starts with the opening of the exhibition on May 7, 2019 and ends on May 9, 2019 at 13:00.

Drawing process

The draw will be manual and will take place on May 9, 2019 at 13:00 at Hall 6, Pavilion #901 of HAPO. There will be one (1) winner and two (2) substitutes.

The winner will be notified via e-mail, (as written in the lottery ticket), where further contact details will be requested to be provided for the purpose of receiving the gift.

All participants in the contest must provide an active e-mail address.

In the event that the communication is not possible, due to technical reasons or other impediment, the winner may be informed of the win and the gift from the Organizer's website, (www.fishfromgreece.com).

The winner is required to respond within fifteen (15) business days of the end of the lottery draw, (May 9, 2019 at 13:00).

If the winner fails to respond within the aforementioned time period, it automatically loses its right to the gift and the Organizer has the right to communicate with the first substitute.

In case the first substitute does not respond within fifteen (15) business days, he automatically loses his right to the gift and the process is repeated to the second (2) substitute with the same time limitation. If the second substitute does not respond, then the gift is canceled.

The gift

The winner in the draw will win a Gastronomy Weekend in Athens.

The gift consists of:

- One lunch and one dinner for two persons in selected restaurants in Athens, specializing in seafood.
- Accommodations for two nights, for a double bedroom in a central Athens hotel, including breakfast.

The gift is already predefined and specific and cannot be transferred, exchanged or redeemed for cash.

The Organizer is only responsible for the availability of the gift specified above. The Organizer does not assume any civil and/or criminal liability against the winner or any third party for any accident and / or damage and / or any physical harm or other damage which may be caused to them directly or indirectly from the gift and its use thereof, or for any other reason.

The winner, at any stage, may be excluded for the following reasons: (a) if, for whatever reason, he does not fully accept these terms as a whole, which are all considered to be essential (b) if its participation does not meet any of the terms, (c) if any of the information it has provided is false, (d) if, for whatever reason, attempting to communicate with the winner is unsuccessful and/or the winner is not found as above and/or found to be late in making use of the prize.

Personal data

Participation in the contest-lottery draw and the filling in of the lottery ticket is a clear statement of consent of the participant within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council.

By filling in the lottery ticket, each participant consent to the processing of their personal data that they voluntarily disclose in the lottery ticket only for the purpose of the drawing.

Participants in the contest provide their consent and authorization to the Organizer to **publish the contest and** its results through the printed and electronic press, social media.

Each participant shall have the right to withdraw his or her consent at any time.

Each participant shall have the right to obtain from the Organizer confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data.

Each participant shall have the right to obtain from the Organizer without undue delay the rectification of inaccurate personal data concerning him or her.

Each participant shall have the right to obtain from the Organizer the erasure of personal data concerning him or her without undue delay and the Organizer shall have the obligation to erase personal data without undue delay.

Each participant shall have the right to obtain from the Organizer restriction of processing.

Various

In the event that the participation drawn to win the gift is void or excluded for reasons stated in these **terms**, then the Organizer will not re-draw **but reserves the right to refer** to the substitutes and/or cancel the contest.

Participants shall not acquire any right in the Trademarks, brands, names, distinctive features, emblems and other insignia of the Organizer.
